MEMBERSHIP CLASSIFICATIONS

All members receive the James River Art League newsletter and are encouraged to attend all meetings, functions and programs, especially the annual business meeting in May.

Exhibiting Members

- Participate in at least two League sponsored art exhibits per year; if this requirement is not met, status will be changed to Associate member.
- To become an Exhibiting member, must submit a completed application form and (3) .jpg images of original artwork by email to the Executive Board via the Membership Chair, by Oct. 15th/Feb. 15th respectively, and be approved for membership by a two-thirds vote of the Executive Board.
- Pay annual dues before participating in League sponsored exhibits.
- May vote and serve on the Executive Board as an Officer or as a Committee Chair

Associate Member

- Does not exhibit in League sponsored art exhibits
- To become an Associate member, must submit a completed application form to the Executive Board via the Membership Chairman by Oct. 15th/Feb. 15th respectively and be approved for membership by a two-thirds vote of the Executive Board.
- Pay annual dues.
- May vote and serve as a committee chair but may not hold office (serve as an Officer on the Executive Board).
- May change membership status to Exhibiting at request if previously juried in as an Exhibiting member; or, if not previously juried in an Exhibiting member, must submit samples of art work as outlined for Exhibiting membership above.

Honorary and Charter Member

- Selected by the Executive Board and voted on by membership for outstanding contribution to JRAL, or may be a Charter Member
- Charter members are all those on the membership roll of the League as of March 15, 1965.
- Not assessed annual dues and may not vote or hold office
